# Sub: Inspection of M/s. INGA Pharmaceuticals, Tamilnadu under Environmental Surveillance of industrial units based on OCEMS data - reg.

Sir,

A team of CPCB officials from CPCB Regional Directorate, Chennai inspected M/s. INGA Pharmaceuticals, Plot No. B1 (part), Phase-II, MEPZ-SEZ, S.F.no. 164/1, Kadaperi Village, Tambaram Taluk, Chengalpattu District, Tamilnadu (The Unit) on 11/09/2024 to verify the compliance status of the industries under Environmental Surveillance of industrial units based on OCEMS data. The Inspection team has observed following short-comings:

- 1. The Unit was not operational due to low demand of products.
- 2. The Unit has not been manufacturing API or bulk drugs for last five years but manufacturing caffeine and herbals products only. The unit shall inform TNPCB when the Unit starts production of API and shall comply with CTO conditions of TNPCB including installation of evaporator.
- 3. As per CTO conditions, the Unit is a ZLD industry, however recycling of treated effluent for toilet flushing in the name of ZLD should not be done.
- 4. The Unit has not provided connectivity of flow meters installed at outlet of the ETP with CPCB server and also camera feed is not streaming at TPDS portal

In view of above:

(i) The Unit shall inform TNPCB and CPCB when the plant starts its operation.

(ii) The Unit shall provide the connectivity of flow meters at outlet of the ETP in addition to storm water drain and ensures uninterrupted camera streaming on TPDS portal, and

(iii) The Unit shall request TNPCB for amendment of CTO conditions based on present manufacturing of herbal products.

The compliance report of the same shall be submitted to this office within 30 days.
