Subject: Ensure installation of Online Continuous Effluent Monitoring System (OCEMS) by Grossly Polluting Industries (GPIs) and it's connectivity to CPCB/SPCBs/PCC servers-reg.

1. CPCB guidelines for OCEMS installation dated 07.11.2014 and July, 2018
2. CPCB directions dated 05.02.2014 u/s 18(1)(b) of the Water (Prevention and Control of Pollution) Act, 1974 for continuous monitoring of industry effluent quality before final disposal to River Ganga and it's tributaries (Ganga River Basin)
3. CPCB office order dated 27&29.12.2016
4. CPCB letter dated 16.12.2022 regarding guidelines for installation of OCEMS in GPIs

Sir,

This is in reference to afore-mentioned CPCB guidelines and CPCB directions dated 05.02.2024 & dated 11.03.2021 issued under section 18 (1) (b) of the water (Prevention and Control of Pollution) Act, 1974 and letter dated 16.12.2022 regarding installation & connectivity of Online Continuous Effluent Monitoring Systems (OCEMS) by Grossly Polluting Industries (GPIs). In compliance to these guidelines/directions, Bihar State Pollution Control Board (BSPCB) was directed to take appropriate actions to ensure installation and connectivity of OCEMS to CPCB and BSPCB server by GPIs.

However, as per the latest inventory of GPIs provided by BSPCB in year-2023, out of 78 GPIs located in your state, 57 GPIs have installed and connected OCEMS to CPCB server and 21 GPIs have not installed and connected OCEMS to CPCB server.

In view of the above, it is again requested to ensure installation & connectivity of OCEMS by 21 GPIs in expeditious time bound manner as per the attached list, in
